### Course

The 5K walkers/runners do one loop for 3.1 miles. The 10K runners do two 3.1-mile loops. Baby joggers are permitted at rear of start line. No in-line skates, and no dogs are allowed.

### Awards

The first 200 registered participants will receive a T-shirt. 10K 1st, 2nd and 3rd place medals in each age group for both males and females (ages under 15, 16-24, 25-39, 40-49, 50-59, 60+). 5K 1st place male and female will receive awards. Participants who provide an email address will receive personal results and a race certificate.

Race starts promptly at 8 a.m., rain or shine; Race Day Registration and packet pick up are from 7-7:45 a.m. Course cut-off is at 10 a.m. Inclement weather may alter or cancel event.
