

**SUPPLEMENTAL ORDERS
PURSUANT TO DECLARATION OF EMERGENCY
VILLAGE OF DEERFIELD, ILLINOIS
MARCH 19, 2020**

I, Mayor Harriet Rosenthal, do hereby issue the following supplemental emergency orders for the Village of Deerfield, this 19th day of March, 2020 ("**Supplemental Orders**").

Introduction

On March 16, 2020, I issued a Declaration of Emergency pursuant to the authority granted to me by: Section 2-137 of "The Municipal Code of the Village of Deerfield, Illinois, 1975," as amended; Section 11-1-6 of the Illinois Municipal Code, 65 ILCS 5/11-1- 6; and Section 11 of the Illinois Emergency Management Agency Act, 20 ILCS 3305/11 to address the health threat posed by the COVID-19 pandemic ("**Declaration**").

The Declaration granted and reserved emergency powers to the Mayor during the pendency of the civil emergency, including the right to issue additional emergency regulations and orders in furtherance of the Declaration.

The corporate authorities of the Village of Deerfield subsequently approved and extended the duration of the Declaration through and until the adjournment of the next regular or special meeting of the corporate authorities of the Village.

Subsequent to the Declaration, Governor Pritzker issued a series of executive orders prohibiting gatherings of more the 50 persons, closing schools, and requiring all restaurants and bars to cease dine-in service statewide. Further, the United States Center of Disease Control recommends for organizations that serve people who are at higher risk of serious COVID-19 illness, cancelling events for groups of 10 people or more.

In order to prevent the spread of COVID-19 in the Village, and to further protect the residents of the Village from disease and death, I find that it is necessary to issue supplemental emergency orders as set forth below. Nothing in the Supplemental Orders shall modify or limit the actions and authority previously established by the Declaration.

Supplemental Orders

I hereby direct and order as follows:

Commencing at 5:00 p.m. on March 20, 2020, the following business within the corporate limits of the Village of Deerfield shall be closed and, for the duration of the Declaration, prohibited from operating as public accommodations open to members of the public or their members:

1. all "Health Clubs," as referred to in "The Deerfield Zoning Ordinance 1978," as amended ("Zoning Ordinance");
2. all "Tennis Clubs," as referred to in the Zoning Ordinance;

3. all "Self Improvement Facilities," including physical exercise and sport training schools, as referred to in the Zoning Ordinance;
4. all "Private Sports Training Facilities," as referred to in the Zoning Ordinance; and
5. all "Personal Fitness Training Centers," as referred to in the Zoning Ordinance.
6. all "Music and Dance Schools," as referred to in the Zoning Ordinance.

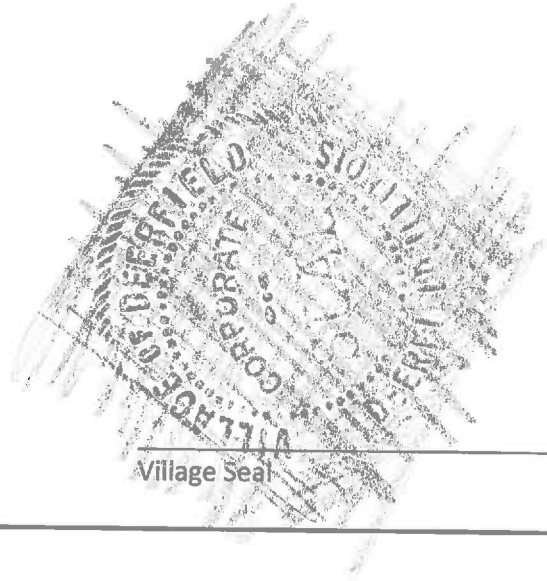
These Supplemental Orders shall take effect immediately, and run concurrently with the term of the Declaration of Civil Emergency unless rescinded or superseded by my order or a majority vote of the corporate authorities at any regular or emergency meeting thereof.
