

**SUPPLEMENTAL ORDER REGARDING PHASE 3  
PURSUANT TO DECLARATION OF EMERGENCY  
VILLAGE OF DEERFIELD  
MAY 30, 2020**

I, Harriet E. Rosenthal, Mayor of the Village of Deerfield, do hereby issue the following supplemental emergency order for the Village of Deerfield this 30<sup>th</sup> day of May, 2020 ("**Supplemental Order**").

Introduction

On March 16, 2020, I issued a Declaration of Emergency pursuant to the authority granted to me by Section 2-137 of "The Municipal Code of the Village of Deerfield, Illinois, 1975," as amended; Section 11-1-6 of the Illinois Municipal Code, 65 ILCS 5/11-1- 6; and Section 11 of the Illinois Emergency Management Agency Act, 20 ILCS 3305/11 to address the health threat posed by the COVID-19 pandemic ("**Declaration**").

The Declaration granted and reserved emergency powers to the Mayor during the pendency of the civil emergency, including the right to issue additional emergency regulations and orders in furtherance of the Declaration.

Since issuance of the Declaration, the corporate authorities of the Village of Deerfield approved and extended the duration of the Declaration. As of the date of this Supplemental Order, the Declaration has been extended through and until June 1, 2020.

In Executive Order No. 2020-10, issued on March 20, 2020, Governor Pritzker directed residents of Illinois to stay at home, subject to limited exceptions, and non-essential businesses to cease operations with limited exceptions. ("**Original Stay-at-Home Order**"). The Original Stay-at-Home Order was extended through April 30, 2020.

In Executive Order No. 2020-32, issued on April 30, 2020, Governor Pritzker entered a new order, renewing, modifying, and updating and extending the Original Stay-at-Home Order ("**Updated Stay-at-Home Order**").

On May 29, 2020, the Governor issued a new Proclamation of the Emergency and Executive Orders 2020-38 and 2020-39, which permit businesses to reopen provided that businesses comply with all applicable guidance issued by the Illinois Department of Commerce & Economic Opportunity and other State agencies (collectively, "**Phase 3 Orders**").

On March 19, 2020, I issued a supplemental order pursuant to the Declaration closing various types of health and sports facilities in the Village ("**March 19<sup>th</sup> Order**").

On April 21, 2020, I issued a supplemental order pursuant to the Declaration requiring the wearing of face coverings in the Village ("**April 21<sup>st</sup> Order**").

On April 2, 2020, I issued a supplemental order pursuant to the Declaration prohibiting at or upon any public place or property the (i) the conduct of any sport or recreational activity using or involving

shared equipment, and (ii) group exercise programs with persons who are not members of the same household or residence ("**April 2<sup>nd</sup> Order**"), which April 2<sup>nd</sup> Order I modified pursuant to a supplemental order issued on May 18, 2020 to permit the playing of racket sports in the Village pursuant to certain conditions ("**May 18<sup>th</sup> Order**").

On May 1, 2020, I issued a supplemental order regarding golf and amending the April 21<sup>st</sup> Order ("**May 1<sup>st</sup> Order**").

In light of the Governor's Phase 3 Orders, and to prevent confusion between the Phase 3 Orders and the supplemental orders I have issued pursuant to the Declaration, I have determined that it is necessary and in the best interests of the Village and its residents to issue a supplemental emergency order as set forth below, (i) repealing the March 19<sup>th</sup> Order, April 2<sup>nd</sup> Order, and May 18<sup>th</sup> Order, and (ii) amending the May 1<sup>st</sup> Order.

In order to prevent the spread of COVID-19 in the Village, and to further protect the residents of the Village from disease and death, and pursuant to the authority set forth in the Declaration, Sections 11-1-6 and 11-20-5 of the Illinois Municipal Code, 65 ILCS 5/11-1- 6, 11-20-5; and Section 11 of the Illinois Emergency Management Agency Act, 20 ILCS 3305/11, I find that it is necessary to issue a supplemental emergency order as set forth below.

Except as expressly provided in this Supplemental Order, nothing in this Supplemental Order modifies or limits the actions and authority previously established by the Declaration or any of the orders that I previously issued pursuant to the Declaration.

#### Supplemental Order

I hereby direct and order as follows:

- A. Repeal of Prior Orders. The March 19<sup>th</sup> Order, April 2<sup>nd</sup> Order, April 21<sup>st</sup> Order, May 1<sup>st</sup> Order, and May 18<sup>th</sup> Order are hereby repealed in their entirety and no longer of force and effect.
  
- B. Face Covering Required. Except as provided in Subsection D of this Supplemental Order, all persons over the age of two are required to wear face coverings to include their nose and mouth made of cloth or other material that is reasonably designed and made to inhibit, filter, or restrict the breath, sneeze, cough, or other exhaling from one's nose and mouth (as further provided and described in Subsection E of this Supplemental Order) while engaging in the following activities:
  - 1. Working in or patronizing retail stores that are open to the public and when employees have contact with the public, which businesses include, without limitation, grocery stores, pharmacies, hardware and supply stores, financial institutions, laundry services, clothing stores, merchandise stores, when picking up food and beverage establishments.
  
  - 2. Working in or visiting an indoor construction site.

3. Performing landscape services.
  4. Riding in public transportation, taxis, or ride share vehicles.
  5. When in indoor common areas of a multi-unit residential, non-residential, or mixed-use building, including, without limitation, elevators, hallways, lobbies, multi-purpose rooms, and parking garages.
  6. When in outdoor common areas of a multi-unit residential, non-residential, or mixed-use property, including, without limitation, common patios, decks, and parking lots, when social distancing of at least six feet from persons who are not members of the same household or residence cannot be maintained. For the purposes of this Section A.6, “members of the same household or residence” shall mean a group of people, whether related or unrelated, who occupy the same dwelling unit on a full-time basis and utilize common cooking, eating, and sanitation facilities.
- C. Refusal of Admission or Service. A business owner or operator must refuse admission or service to any individual who fails to wear a face covering as required by this Supplemental Order.
- D. Exceptions. Subsection B of this Supplemental Order does not apply in any of the following circumstances:
1. When a person is engaged in outdoor activity and permissible outdoor physical activity (such as walking, hiking, running, or biking), provided that the person practices social distancing of at least six feet from persons who are not members of the same household or residence. For the purposes of this Section D.1, “members of the same household or residence” shall mean a group of people, whether related or unrelated, who occupy the same dwelling unit on a full-time basis and utilize common cooking, eating, and sanitation facilities.
  2. When riding in a personal vehicle.
  3. When a person is alone or with others in a private space that is not open to the general public unless otherwise required by Sections B.5 and B.6 of this Supplemental Order.
  4. Those for whom wearing a face covering is not medically advisable.
- E. Types of Face Coverings. Appropriate face coverings include manufactured masks, homemade masks, scarves, bandanas, or handkerchiefs.
- F. Medical-grade Masks. Medical-grade masks and N95 respirators are not recommended for general public use under this Supplemental Order, and should be reserved for use by health care and medical providers and first responders.


- G. Signs. A sign shall be posted in the lobbies or entrance ways of all multi-unit residential, non-residential, and mixed-use buildings notifying unit owners, tenants, and their guests of the requirements of Sections B.5 and B.6 of this Supplemental Order.

Nothing in this Supplemental Order shall supersede or relieve any person from complying with the social distancing and face covering requirements set forth in Governor Pritzker's Executive Orders. Social and physical distancing is still the first and most effective practice to combat the COVID-19 pandemic. Nothing in this order shall supersede or relieve any person from complying with prior order's issued pursuant to the Mayor's Declaration except as expressly provided herein.

This Supplemental Order will take effect immediately upon execution, and run concurrently with the term of the Declaration of Civil Emergency unless rescinded or superseded by my order or a majority vote of the corporate authorities at any regular or emergency meeting thereof.
